# What do chiropractors do?

Chiropractors are health care professionals concerned with the diagnosis, treatment, and prevention of disorders to the neuromusculoskeletal system.





### Neuromusculoskeletal system?

**Neuro** = **Nervous System** 

Musculo = Muscular System

Skeletal = Skeletal System

# How do chiropractors provide treatment?

Treatment methods include exercises and lifestyle counseling. More specifically, physical manipulation of the spine, joints, and soft tissue are conducted by chiropractors.





# Chiropractics

Chiropractors can also treat many other disorders such as digestive issues, asthma, numbness, recurrent colds, sciatic, chronic fatigue, chest pain, headache, sports injury

# **Admissions**



- CGPA of 2.50 on a 4.00 grade point scale: Average GPA of admitted students is 3.1
- Must complete at least three full years of undergraduate university study in Canada (15 full year courses or 90 credit hours).
- Complete as of May 31st of the year in which one applies in.
- ▶ Proficiency in English
- ►No pre requisite courses needed.

- Recommended courses:
  - One full course (with labs): organic chemistry and biology
  - One Half Course: introductory psychology
  - One and One Half Course: Humanities and or Social Sciences

Part C - Have official academic transcripts sent directly to CMCC.

Published Deadline: November 15<sup>th</sup>, 2019 is the deadline for the 2020 admission cycle.

#### **Interview Process**

- Interviews are granted if applicants meet the undergraduate CGPA (2.5 on a 4.0 scale)
- The video interview lasts approximately 30 minutes
- ► The interview team considers: communication, collaboration, management, health advocacy, scholarship and professionalism

#### **Interview Process**

- ► The ideal candidate will have:
  - Chiropractic experience: through job shadowing/volunteering at a chiropractic clinic or being a chiropractic patient
  - Conducted your own research on the chiropractic profession
- All applicants will be notified of their application outcome by mid April.

# Program Outline

Four year Doctor of Chiropractic (DC) Degree

Year I & Year II

Students build their foundation of knowledge in basic sciences and pathology for clinical skills and decision making while also getting hands on experience through courses in chiropractic skills, diagnosis and symptomatology, orthopaedics and diagnostic imaging.

# **Program Outline**

#### Year III

- Emphasizes knowledge integration through the use of case-based clinical material to prepare students for internship in the CMCC clinics.
- ► The basic sciences from Years I and II are integrated into the clinical and diagnostic sciences by providing laboratory diagnosis, pathology, and clinical nutrition classes.

# **Program Outline**

#### Year IV

is a 12 month clinical internship in two of CMCC's clinical settings where interns provide direct care and education to patients under the supervision of a licensed chiropractor. Year IV students also engage laboratory clerkships and advanced diagnostic imaging, public health and business management.

#### **CCEB National Competency Examinations**

Candidates who wish to practice chiropractic in a Canadian province must obtain a <u>CCEB Certificate</u>.



#### Application for Licensure

Once a chiropractor has graduated from an accredited DC Program and obtained a CCEB Certificate, he or she must apply for licensure in a Canadian province. Each <u>Provincial Licencing Office</u> has unique requirements for licensure and should be contacted as soon as possible.

- ► Canadian Chiropractic Examining Board (CCEB)
  - ► Offered 3x/year February, June & October
- Component A Chiropractic Knowledge
- ► Component B Clinical Decision Making & Diagnostic Imaging

# Component A

- You will be tested on
  - Your understanding of terminology (or vocabulary);
  - Your understanding of fact and principle (or generalization);
  - Your ability to make evaluative judgments;
  - Your ability to arrive at an appropriate diagnosis on the basis of the information provided in a clinical vignette; and
  - Your ability to make appropriate patient management recommendations on the basis of information provided in a clinical vignette.

### Component B

- You will be tested on
  - Your understanding of terminology (or vocabulary);
  - > Your understanding of fact and principle (or generalization)
  - > Your understanding of radiographic images;
  - Your ability to recommend appropriate actions (in some specific practical problem situations);
  - > Your ability to make evaluative judgments;
  - Your ability to arrive at an appropriate diagnosis on the basis of the information provided in a clinical vignette;
  - > your ability to make appropriate patient management recommendations on the basis of information provided in a clinical vignette.

#### **COMPONENT C**

- Candidates will be assessed on their ability to:
  - Ability to obtain relevant history information through a patient interview
  - Ability to perform relevant physical examinations and interpret the findings
  - Use physical examinations to differentiate conditions
  - Utilize history and physical examination information to formulate diagnoses, differential diagnoses, treatment recommendations, and plans of management
  - Communicate with the patient to explain findings, diagnoses, treatment recommendations and plans of management
  - Obtain informed consent
  - > Demonstrate appropriate chiropractic treatment skills
  - > Respond to patient questions, concerns and behaviors

# **Application for Licensure**

After graduation from an accredited DC program and obtaining a CCEB Certificate, you must apply for a Chiropractic licence

Please note that each province has unique requirements for provincial licensure

# College of Chiropractors of Ontario (CCO)



- Graduated from an accredited chiropractic college (CMCC)
- Obtained CCEB Certificate
- Completed CCO Legislation and Ethics Examination (offered during the same week as CCEB exams)
  - Offered 3x/year
  - ▶ 2 hour open book examination
  - **\$180**
